	c. <b>Master's degree:</b> <ul style="list-style-type: none"> <li>baccalaureate diploma + transcript, bachelor's degree + transcript + certificate of proficiency in Romanian language, minimum level B1 for <b>study programs taught in Romanian</b></li> <li>baccalaureate diploma + transcript, bachelor's degree + transcript + certificate of proficiency in English language, minimum level B1 for <b>study programs taught in English</b> (link <a href="#">Appendix 7_List of recognized language proficiency certificates EN</a>)</li> </ul>
